City Council News

A Public Hearing was held at 7:00 PM in the council chambers at which time any citizen of Early, Iowa or any other person having interest in the proposed Designation of the Early Revitalization Area 2016 and The Adoption of a Plan for Such Revitalization Area as published in the Chronicle on November 24, 2016 may appear and be heard for or against the adoption of the proposed Early Revitalization Area or any part thereof. One resident was present. No residents or taxpayers were either for or against said Urban Revitalization proposed. Hearing was closed.

A regular meeting of the City Council of the City of Early, Iowa was held on the 6th day of December, 2016. The meeting began with the Pledge of Allegiance. Mayor Sharon Ann Irwin called the meeting to order at 7:03 p.m. with a roll call as follows: Present: Brian Pickhinke, Doug Gulley, William Cougill, and Mary Ann Brinkman. Absent: Melissa Freese. A motion was made by Councilor Cougill and seconded by Councilor Brinkman to approve the consent agenda including; agenda, minutes, and bills for payment. Ayes: Gulley, Cougill, Brinkman, and Pickhinke. Nays: None. Absent: Freese. Motion carried.

City Council discussed a citizen complaint regarding a high water bill due to a leak no action was taken. City Council also discussed a complaint from a resident that received a parking warning for parking on the street during the snow ban no action was taken.

A motion was made by Pickhinke and seconded by Brinkman to table the Resolution Setting the Salaries for Appointed Officers and Employees of the City of Early for the Year 2017 due to lack of quorum. Ayes: Gulley, Cougill, Brinkman, and Pickhinke. Nays: None. Absent: Freese. Motion carried.

Resolution 16-29 – Authorization to change Health insurance plans for 2017 was offered by Councilor Pickhinke and seconded by Councilor Brinkman. On roll call vote. Ayes: Gulley, Pickhinke, Cougill, and Brinkman. Nays: None. Absent: Freese. Whereupon the Mayor declared said resolution duly adopted. A copy of said resolution is attached hereto and by the reference made a part thereof.

Resolution 16-30 – Authorizing the City Clerk of the City of Early to Certify Certain Unpaid Utility Rates or Charges to the County Treasurer was offered by Councilor Pickhinke and seconded by Councilor Gulley. On roll call vote. Ayes: Cougill, Gulley, Pickhinke, and Brinkman. Nays: None. Absent: Freese. Whereupon the Mayor declared said resolution duly adopted. A copy of said resolution is attached hereto and by the reference made a part thereof.

Resolution 16-31 - Stating the Indentions of the City Council with Regard to the Designation of the Early

Revitalization Area 2016 and the Proposed Plan Therefor was offered by Councilor Pickhinke and seconded by Councilor Gulley. On a roll call vote: Brinkman, Cougill, Gulley, and Pickhinke. Nays: None. Absent: Freese. Whereupon the Mayor declared said resolution duly adopted. A copy of said resolution is attached hereto and by the reference made a part thereof.

A motion was made by Councilor Cougill and seconded by Councilor Gulley to repair the building in the cemetery for the estimated cost of 2710.48. Ayes: Brinkman, Gulley, Cougill, and Pickhinke. Nays: None. Absent: Freese. Motion carried.

Public Works, Mayor and City Clerk gave reports. Sheriff's written report was available for review. A motion was made by Councilor Brinkman and seconded by Councilor Cougill to adjourn. The meeting was adjourned at 7:57 PM on voice vote.
