## **City Council News**

A regular meeting of the City Council of the City of Early, Iowa was held on the 2nd day of November 2021. The meeting began with the Pledge of Allegiance. Mayor Sharon Ann Irwin called the meeting to order at 7:05 PM with roll call as follows: Present: Brian Pickhinke, Bill Cougill, Tim Langner. Absent: Steven Mason, Summer Schmitt. A motion was made by Councilor Pickhinke and seconded by Councilor Cougill to approve the consent agenda including agenda, minutes, bills for payment. On show of hands: Ayes: Pickhinke, Cougill, Langner. Motion passed. A motion was made by Councilor Cougill and seconded by Councilor Bill Cougill to approve building permit #790. On a show of hands: Ayes: Cougill, Pickhinke, Langner. Motion passed. A motion was made by Councilor Pickhinke and seconded by Councilor Langner to approve building permit #791 pending P & Z Committee approval. On a show of hands: Ayes: Pickhinke, Cougill, Langner. Motion passed. Resolution 21-21 Annual State of Iowa Road Use Tax Funds was offered by Councilor Pickhinke and seconded by Councilor Cougill. On a roll call vote. Ayes: Pickhinke, Cougill, Langner. Whereupon the mayor declared said resolution duly adopted. A motion was made by Councilor Pickhinke and seconded by Councilor Cougill to have the Mayor sign a notice of intent letter written and prepared by ISG and Region XII to follow the necessary steps to for CDBG guidelines in offering to purchase land for the Drainage District 59 project. On a show of hands. Ayes: Pickhinke, Cougill. Nays: Langner. Motion passes by majority vote. Wes Boyer from Bolton and Menk came to give updates for the 2nd Street watermain project. Schmitt Construction is asking for an extension on time as not all the materials needed have arrived and are in high demand. As of right now the City will stay in close contact with Schmitt Construction to determine time extensions that will need to be given. We will be waiting for material to show up first before that decision is made. The Council was updated on several properties within City limits that were still in violation of the City Ordinances. The properties listed will be going back to court for trial. The council was updated on other nuisances for the month. Monthly reports were given by the Mayor, Library, Fire Dept, and DPW. #### **Mayor's Notes**

The Council again discussed with the Drainage District 59 Engineer, the necessary paperwork needed to proceed with the retention pond and the replacement of the drainage tile through the community.

The Second Street water project was again discussed as we are reaching the end of the construction season. The contractor is still waiting for parts to complete connections for fire hydrants. If the necessary parts aren't received very soon, a decision will need to be made to stop the project until spring. Exposed pipe will have to be buried for the winter, if the project can't be finished now.

There will be two court dates on November 9th for municipal infractions and one will be on December 14th.

We will continue the water conservation watch through the winter. Although we have had nice rains, our wells have not made a comeback. The community has been doing well with this and we ask you to continue.

Remember that dogs are to be leashed. There have been complaints of people out walking and having dogs coming after them.

Congratulations to all those who won elections on Tuesday and thank you to those who also ran.

Remember all vehicles off the streets between midnight and 7 am.

## **Early Code of Ordinances Reminders**

Chapter 55- At Large Prohibited `It is unlawful for any owner to allow an animal to run at large within the corporate limits of the City.` (Keep pets on a leash at all times unless supervised on property)

Chapter 56- City Cat & Dog License Required `Every cat or dog being kept, harbored, or sheltered in the City limits shall be licensed annually. (Jan 1st)

Chapter 75- All-Terrain Vehicles and Snowmobiles `No person shall operate an ATV and off-road utility vehicles on any City street without first obtaining a permit from the City. (Jan 1st)

Chapter 77- Golf Carts and Small Recreational Vehicles. `No person shall operate a golf cart, small rec vehicle, or motorized wheelchair on any city street without first obtaining a permit from the City. (Jan 1st)

Chapter 150- Building Numbering `Building numbers need to be displayed on the house/business in a conspicuous place and no less than 2 1/2" tall and of contrasting color.
