# City Council News

A regular meeting of the City Council of the City of Early, Iowa was held on the 6th day of October 2015. The meeting began with the Pledge of Allegiance. Mayor Sharon Ann Irwin called the meeting to order at 7:00 p.m. with a roll call as follows: Present: Brian Pickhinke, William Cougill and Melissa Freese. Absent: Vincent Davis and Mary Ann Brinkman. A motion was made by Councilor Cougill and seconded by Councilor Freese to approve the consent agenda including; agenda, minutes, and bills for payment. Ayes: Pickhinke, Cougill, and Freese. Nays: None. Absent: Brinkman and Davis.

Resolution 15-20 Approving The Memorandum of Understanding with the Iowa Department of Administrative Services was offered by Councilor Pickhinke and seconded by Councilor Cougill. On a roll call vote. Ayes: Freese, Cougill, and Pickhinke. Nays: None. Absent: Davis and Brinkman. Whereupon the Mayor declared said resolution duly adopted.

Resolution 15-21 Authorizing a Monthly Transfer of Funds From The Local Option Sales Tax Fund to the General Fund For Tax Relief was offered by Councilor Cougill and seconded by Councilor Freese. On roll call vote. Ayes: Cougill, Pickhinke, and Freese. Nays: None. Absent: Brinkman and Davis. Whereupon the Mayor declared said resolution duly adopted.

Resolution 15-22 Authorizing The City Clerk to Pay Specified Claims Prior to Council Approval Offered by Councilor Freese and Seconded by Councilor Cougill On a roll call vote. Ayes: Pickhinke, Freese, and Cougill. Nays: None. Absent: Davis and Brinkman. Whereupon the Mayor declared said resolution duly adopted. A copy of said resolution is attached hereto and by the reference made a part thereof.

A motion was made by Councilor Pickhinke and seconded by Councilor Freese to have the city submit an application to Mid-American Trees Please program. Tammy Nuckolls and Jerry Irwin will sit on the trees please committee. Ayes: Pickhinke, Freese, and Cougill. Nays: None. Absent: Davis and Brinkman.

A motion was made by Councilor Pickhinke and seconded by Councilor Brinkman to have the City of Early sign the MidAmerican Energy Company LED Street Lighting Installation Agreement for all Early street lights and to sign the Customer Request Form to replace 8-HU7 400HPS street lights to LED fixtures at a cost to the city of \$100.00 per fixture. Ayes: Cougill, Brinkman, Pickhinke, and Freese. Nays: None. Absent: Davis. Supt. D.P.W., Mayor, and City Clerk gave monthly reports. Sheriff's monthly written report was reviewed.

A motion was made by Councilor Freese and seconded by Councilor Brinkman to accept MidAmerican Energy Company's proposal of \$8947.85 to remove existing overhead electric facilities and install new facilities along Highway 71 going to city shop. Ayes: Cougill, Brinkman, Pickhinke and Freese. Nays: None. Absent: Davis

A motion was made by Councilor Cougill and seconded by Councilor Pickhinke to adjourn. The meeting was adjourned at 8:25PM on voice vote.

#### A Message from the Mayor,

I have had numerous questions about the new sidewalks along the highway. This was all done by the Iowa Department of Transportation. It is my understanding that if the adjacent property owner did not sign easement papers for this project about two years ago, the sidewalk in front of their property was not replaced. The City had no part in this project.

Have you noticed the new sign on the front of the fire station? The old one was going to be repainted but it was found to be in very bad shape so a new sign and design was purchased. It makes for a nice update to the building.

If you saw someone from the DNR driving around town a few weeks ago, they were doing a tree inventory for us. This information will go onto a GIS program that will show where a tree is, what kind it is and the condition of the tree. The City will then be able to access this information and help to make plans in and for the future.

The City has been going door to door doing an income survey to help us apply for a Housing Rehabilitation Grant. If the grant is approved, it can possibly help low to moderate homeowners (living in their own home) to make improvements to their home.

It is hoped that the new maintenance garage will be going up yet this month. With all the rain this summer, the contractors are behind schedule. Once it is completed, City equipment will be housed inside instead of setting out in all the weather.
