City Council News

A Public Hearing was held at 6:00 PM on the 5th day of March 2024 in the municipal building at which time any citizen of Early, Iowa or any other person having interest in the proposal to enter into a general obligation loan agreement as published in the Chronicle on February 22nd, 2024, may appear, and be heard for or against the adoption of the general obligation loan agreement or any part thereof. No residents or taxpayers were for or against said budget. The hearing was closed at 6:02. Resolution 24-05 Taking additional action on proposal to enter into a general obligation loan agreement and providing for the levy of taxes to pay general obligation corporate purpose note was offered by Councilor Pickhinke and seconded by Councilor Scadden. On a roll call vote. Ayes: Pickhinke, Scadden, Langer, Madden. Absent: Blackman. Whereupon the mayor declared said resolution duly adopted. A regular meeting of the City Council of the City of Early, Iowa was held on the 5th day of March 2024. The meeting began with the Pledge of Allegiance. Mayor William Cougill called the meeting to order at 6:00 PM with roll call as follows: Present: Brian Pickhinke, Brandon Scadden, Tim Langner, Christine Madden. Absent: Becky Blackman. A motion was made by Councilor Languer and seconded by Councilor Scadden to approve the consent agenda including agenda, minutes, bills for payment. On show of hands: Ayes: Pickhinke, Scadden, Lagner, Madden. Absent: Blackman. Motion passed. Citizen Input- C. Bainbridge was present to express her concerns to the council about the boring in the ROW in front of her home. She explained to the council that her sewer line runs right through where the Cornbelt sub-contractor was boring and where they placed a box a few months ago. In was discussed that in this particular location there are several utilities that run alongside the sewer. She had to recently repair her sewer line and the cost of the replacement was much higher than anticipated due to the many utilities running through the area. The Council suggested she start with getting ahold of a representative with Cornbelt to discuss the boring furthermore with them. Chris Dodd with Evertek was present and wanted to talk with the council on the partnership they have had the last 10 years and how they are coming to rural Early with fiber and would like to come into City limits. Chris explained to the council that with recent developments he wanted to make sure that Evertek sticks with their customers through the changes. The council drilled him on some things they have witnessed with the other fiber company coming in and wanted to know how Evertek would respond to some of these issues. The council was pleased with his responses and answers. A motion was made by Council Pickhinke and seconded by Council Scadden to allow Evertek to come into city limits to lay fiber in town for potential customers. On show of hands: Ayes: Pickhinke, Scadden, Lagner, Madden. Absent: Blackman. Motion passed. The City Attorney was not present. A motion was made by Councilor Languer and seconded by Councilor Scadden to set Public hearing date for Property Tax Levy for April 2nd, 2024, at 6:00pm ONLY ITEM. On a show of hands. Ayes: Pickhinke, Scadden, Lagner, Madden. Absent: Blackman. Motion passed. The Clerk reported the following receipts and bills that were approved for payment in the consent agenda: A motion was made by Councilor Pickhinke seconded by Councilor Scadden to adjourn the meeting at 8:12 PM. Meeting closed.
