RESOLUTION SETTING FEES FOR THE CITY OF EARLY, IOWA

BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF EARLY, IOWA WHEREAS, the City has a need to implement certain fees for services provided to residents, visitors, and private businesses utilizing various City services and facilities from time to time, and,

WHEREAS, certain chapters and sections of the City's Code of Ordinances provide for various permit fees, fines, and services provided, and,

WHEREAS the following fees, fines, and costs for service are proposed:
