AUTHORIZATION FOR THE PURCHASE OF ONE 2019 DODGE RAM 2500 PURSUANT TO PURCHASE AGREEMENT ATTACHED HERETO, AND AUTHORIZATION FOR THE USE OF FUNDS FROM THE GENERAL FUND AND TRANSFER FROM THE EQUIPMENT REPLACEMENT FUND TO THE GENERAL FUND

WHEREAS, City of Early has authorized Public Services Director, Kris Alesch to negotiate a purchase agreement for one 2019 Dodge Ram 2500 pickup with the specifications as shown on the attached Purchase Agreement, which agreement is incorporated herein by this reference, and the City should accept said offer and authorize the execution of the purchase agreement and the purchase; and

WHEREAS, the City has funds available in the Equipment Replacement Fund to pay for the purchase of the pickup after a transfer into that account from the IPAIT account; and

NOW, THEREFORE, IT IS RESOLVED by the City Council of the City of Early, Iowa, as follows:

Section 1. That the City Clerk be and is authorized to transfer the sum of \$ 21,500 from the IPAIT account to the Equipment Replacement Fund and further authorized to pay up to \$ 21,500 from said fund to the titleholder of the pickup and make arrangements for the acquisition of the pickup and to do all things necessary in furtherance of the purpose of this resolution.
